## MANAGING PRINCIPAL

### REPRESENTATIVE CASES

- **Minority Shareholder Representation (Business Divorce)** – Lead counsel in lawsuit by minority shareholder against majority owners for breach of fiduciary duty, conversion, and fraud, after majority owners attempted to sell company without client's knowledge or consent.
- **Minority Member Representation (Business Divorce)** – Counsel for well-known local attorney client in litigation over buyout of client's membership interest in law firm (a PLLC).

- **Minority Shareholder Representation** – Litigation counsel for dissenting minority shareholder in dispute over majority shareholders' effort to force sale of company through reverse-triangular-merger.
- **Company Dissolution** – Counsel for shareholder in local construction contractor in negotiated dissolution and wind-up of company affairs, after client accused of fraud and breach of fiduciary duties.
- **LLC Dissolution** – Representation of equal owner of local apparel company in negotiated dissolution of Limited Liability Company.
- **Majority Investor Representation (Business Divorce)** – Lead counsel for majority investor in strategic force-out of operating minority owner's interest in local restaurant, giving client 100% control of company.
- **Majority Investor Representation (Business Divorce)** – Lead counsel for majority investor in forced dissolution and windup of Portland based whiskey distillery and restaurant.
- **Minority Member Representation** – Lead counsel for minority owner in negotiated resolution of claims against majority owner for breach of fiduciary duty and breach of loyalty in connection with the operation of single asset real estate LLC.
